Addendum: Please note updates to EFM Policies. The following addresses specific product areas:

Vendors vending as Home Bakery are welcome to apply to vend at the EFM however Licensed Bakeries with similar products will be given preference. Items sold as Home Baked goods at the EFM should have a sign at the market stand stating the products are produced in a Home Bakery not subject to state inspection, additionally packaged items should be labeled;

Made in a Home Kitchen

Name and Address of baker

ingredients in descending order

The State of Wisconsin defines a home bakery as one which is selling less than \$5,000 in product per year. All home baked goods must be shelf stable; requiring no refrigeration.

Vendors wishing to vend CBD/Hemp Oil products must provide a license, Fit For Commerce Certificate, and must abide by all claim restrictions (i.e. not allowed to advertise in print or verbally that product cures X)
